Residents have been in contact with the Parish

Council for assistance in liaising with Thakeham regarding possible tree works.

- **b)** Site A39 Land to the North of West Horsley: Nothing to report. It was agreed that Deputy Clerk will contact the GBC case officer for an update.
- c) Site A38 Land near Horsley Railway Station, Ockham Road North, East Horsley An update has been requested from SCC Flood Teams with regards to outstanding drainage issues.

25.PE.112 Special Projects:

- Site A35 Land at former Wisley Airfield: Discharge of Condition 88: Cycle Route Mitigation Strategy has been submitted. Whilst it relates predominantly to the Ripley Off-Site Cycle Route, it also details the lighting proposals for all the Off-site Cycle Routes. The Parish Council is not a statutory consultee for Discharge of Conditions and as such the decision is made solely by the case officer. However, there are concerns relating to the Horsley Cycle Route including lighting and practicalities in implementing the route. Deputy Clerk to liaise with SCC, WH Place and East Horsley Parish Council to consider how to proceed with a view to arranging a meeting to discuss further.
- **Surrey Hills National Landscape:** As the boundary consultation is now complete although yet to be adopted, it was agreed that this item can be removed from the next planning committee agenda.
- 25.PE.113 To agree any requirement for external advice in relation to applications considered: The planning application for Blakes Lane Farm (item 25.PE.107 d) was discussed. It was agreed that the case officer should be contacted to see if there was enough time to instruct an external planning consultant at this stage prior to a decision being made.
- 25.PE.114 **To consider if and when it is appropriate to commission a Housing Needs Survey:** It was agreed that, in view of the continuing changes in planning policy together with the ongoing local government reorganisation, advice would be sought from GBC as to whether this is the optimum time to undertake a housing needs survey.
